# WARRANTY

## PRODUCT WARRANTY

**This Limited Warranty (“Warranty”) applies to physical goods purchased under the trademark Mo’cycle® (“Product”) from Airbag Inside Sweden AB (“Company”). The Warranty covers any defects in material or workmanship under normal use during the Warranty Period, as defined below.**

## WARRANTY COVERAGE

The Company warrants that the Product will be free from defects in material and workmanship under normal use and maintenance during the Warranty Period. If a defect arises within the Warranty Period, the Company will, at its sole discretion, either repair or replace the Product or its defective parts, free of charge.

## REPAIR OR REPLACEMENT

In the event of a covered defect, the Company will either repair the Product or replace it with a new or refurbished Product or parts. The repaired or replaced Product or parts will be covered by this Warranty for the remainder of the original Warranty Period or for 90 days, whichever is longer.

## WARRANTY PERIOD

The Warranty Period for the Product starts from the date of purchase and lasts for 2 years (“Warranty Period”). The original proof of purchase, such as a sales receipt or invoice, may be required to validate the Warranty Period. If a replacement Product or part is provided under this Warranty, the remaining Warranty Period of the original Product will apply to the replacement Product or part.

## WARRANTY LIMITATIONS

This Limited Warranty does not cover any problem, damage, or defect that is caused by: Conditions, malfunctions, or damage not resulting from defects in material or workmanship. Defects in the fabric’s color and coating caused by wear and tear or washing. Normal wear and tear of the airbag activation trigger if activated under circumstances other than a real-life accident. An accident in which the Product was involved. Products used in an accident cannot be repaired or replaced under this Warranty.

**DISCLAIMER OF OTHER WARRANTIES**

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE COMPANY DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT.

**LIMITATION OF LIABILITY**

To make a claim under this Warranty, please contact the Company's Customer Support within the Warranty Period. You may be required to provide proof of purchase and a description of the alleged defect. The Company will provide further instructions on how to proceed with the claim.

**GOVERNING LAW AND JURISDICTION**

This Warranty shall be governed by and construed in accordance with the laws of the jurisdiction in which the Product was purchased. Any disputes arising out of or in connection with this Warranty shall be subject to the exclusive jurisdiction of the courts in that jurisdiction.

**ENTIRE AGREEMENT**

This Warranty constitutes the entire agreement between the user and the Company regarding the Product and supersedes all prior or contemporaneous understandings, representations, warranties, or agreements, whether written or oral, regarding the Product.

**SEVERABILITY**
